



**IBCA Congress**  
**Rodos Palace Hotel, Island of Rhodes, Greece**  
**October 15, 2023, 10:00**  
**Minutes**

Dr. Charudatta Jadhav, President, opens the Congress at 10:00 and welcomes all participants present in the meeting room and remotely on the Zoom conference. He deplores the death of Ludwig Beutelhoff, former President and Honourary President of IBCA, and of Stephen Hilton, former vice-president and board member. Their contribution to braille chess will never be forgotten. The Congress observes a minute of silence.

The reports drawn up by the nomination commission and the treasurer recommend, in accordance with article 2.6 of the Statutes, that only members up to date with their 2023 fee be authorized to take part in the vote. Natasha Dalle, treasurer and member of the nomination commission, reads a list of 38 countries.

Dr. Jadhav requests the Congress to grant voting rights to countries that have paid their fee less than 60 days before the date of the Congress. This proposal is unanimously approved by the Congress.

Natasha Dalle recommends the temporary exclusion of member countries that have not paid their dues for 5 years, and reads a list of 16 countries:

Dr. Jadhav proposes to appoint Sorin Lapadatu (Romania) as election officer, assisted by N. Nandakumar (India). The Congress approves these appointments unanimously.

Nikos Kalesis, first vice-president, reads the president's report. This report is unanimously approved by the Congress.

Dr. Jadhav underlines the commitment made by DGT to provide 100 clocks free of charge to IBCA, at the rate of 20 clocks per year, and proposes to grant the DGT company the position of associate member, without voting rights. This proposal is unanimously approved by the Congress.

Natasha Dalle, treasurer, reads the financial report. This report is unanimously approved by the Congress.

Dr. Jadhav proposes to discharge the entire board, which is unanimously approved by the Congress.

Dr. Jadhav receives Congress' applause for his 23 years of service to IBCA. He wishes good luck to both candidates, and entrusts the conduct of the Congress to Sorin Lapadatu, elections officer.

The two candidates, Sergio Harnandan (Netherlands) and Jorgen Magnusson (Sweden), briefly present their program.

Diana Tsykina (Canada) contests the fact that some countries were excluded from voting for not having fulfilled their financial obligations to IBCA. She is told that she could take legal action if she wishes to contest the election results.

Delegates are then called to vote in alphabetical order. Black and white and braille ballots are available.

The elections officer and his assistant count the ballots.

Sorin Lapadatu, elections officer, announces the result of the vote

Magnusson list: 23 votes

Harnandan list: 11 votes

Jorgen Magnusson (Sweden) is elected president of IBCA. He thanks his supporters and congratulates his opponent. Sergio Harnandan congratulates Jorgen Magnusson on his election, and wishes him good luck. The Congress applauds both candidates.

Jorgen Magnusson submits the composition of his board to the Congress. The members of the board are appointed one by one, and are unanimously approved by the Congress.

Unanimously approved by the Congress.

Jorgen Magnusson proposes to appoint Dr. Charudatta Jadhav Honourary President, for all his work accomplished in the service of IBCA. Proposal unanimously approved by the Congress, to applause.

New countries have expressed an interest in joining IBCA:

Kenya, Philippines, Mongolia, Czech Republic

These memberships are unanimously approved by the Congress.

Proposals have been submitted to the Congress by several member countries.

South Africa and Nicaragua propose reducing the annual fee for developing countries.

It is difficult to create multiple categories of members. Jorgen Magnusson proposes reducing the annual membership fee from 150 euros to 50 euros for all member countries from 2024. In order to offset the impact of this measure on the finances of IBCA, an individual registration fee may be asked of tournament participants. Dr. Jadhav believes that youth and women's tournaments, as well as continental championships from developing regions should be exempted from this entry fee. New member countries will benefit from a free first year. The contribution for the second year will be 25 euros, and the contribution will increase to 50 euros from the third year.

The amount of the new fee is unanimously approved by the Congress. The board will make proposals for registration fees for tournaments taking place after 2025.

Ukraine proposes to apply the measures already included in the statutes regarding medical certificates and vision control of tournament participants.

It is difficult and expensive to control the sight of all participants in a tournament. Jorgen Magnusson proposes to check the sight of 5 low vision players during each tournament. The board will work on this matter and make proposals.

IBCA America makes several proposals:

- Separate players B1 (blind) and B2-B3 (low vision)
- Create rapid individual and team tournaments
- Declare the loss of the game for visually impaired players after 4 illegal moves instead of 2 currently
- Organize IBCA worldwide tournaments in all parts of the world

IBCA cannot impose the organization of tournaments on several continents, but will do everything possible to make this happen.

About illegal moves and the organization of rapid tournaments, IBCA does not mind these measures being applied in America.

About the separation between B1 and B2-B3, the situations are very different depending on the region of the world. For instance, there are quite few B1 players in Europe. Additionally, it seems very expensive for a country to send two teams to the Olympiads, one composed of B1 players and the other of B2-B3

IBCA will observe with great interest the experiences carried out in America, and will be able to draw inspiration from them in the future.

Germany sent several proposals regarding the time control, the role of captains and the moves notation in time scramble.

The board will make proposals, in consultation with FIDE and the arbiters commission.

With no one asking to speak, President Jorgen Magnusson thanks all the participants. The Congress closes at 13:10.
